

NOTICE OF 15-DAY PUBLIC REVIEW AND COMMENT PERIOD

DRAFT 2011 ANALYSIS OF IMPEDIMENTS TO FAIR HOUSING CHOICE

PUBLIC REVIEW PERIOD: The draft 2011 Analysis of Impediments to Fair Housing Choice (AI) is available for public review and comment for a 15 day period beginning Friday, **September 16, 2011** and concluding Monday, **October 3, 2011**

The Department of Housing and Urban Development requires jurisdictions, such as Sunnyvale, that receive federal Community Development Block Grant (CDBG) and Home Investment Partnership (HOME) funds to update their AI documents every three to five years. The AI evaluates potential barriers to fair housing choice and describes actions the City will take to address identified impediments. It is intended as a guide for jurisdictions to use in developing policies and implementing activities related to or affecting fair housing choice.
