The City of Sunnyvale is preparing its Draft Consolidated Plan which describes the City's affordable housing and community development priority needs, resources and strategies for the next five fiscal years (2010-2015).

Preparation and adoption of the Consolidated Plan is required by the federal Department of Housing and Urban Development (HUD), in order for the City to receive two HUD grants: the Community Development Block Grant (CDBG) and HOME Investment Partnership Programs Grant.

The Plan establishes priorities and goals for the provision of housing, public services, economic development, facilities and infrastructure, primarily for low and very low-income persons, including homeless people.

The City invites residents and other interested parties to provide comments and input regarding the 2010-2015 Consolidated Plan, and use of the City's HUD grants during the next five years. **Please attend one of these meetings to learn more and to provide your input on this important community plan.**
