REPORT IN BRIEF

On April 26, 2011, the City Council approved a request to rename Capella Way to Olson Way. This report contains the required resolution to carry out the street name change action.

DISCUSSION

City Council Policy 1.1.14 requires City Council action taken on the renaming of streets to be completed through the adoption of a resolution. The City Council approved the renaming of Capella Way to Olson Way on April 26, 2011. An adopting resolution was not included with the Report to Council. **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SUNNYVALE APPROVING CHANGING THE STREET NAME
CAPELLA WAY TO OLSON WAY LOCATED IN DOWNTOWN
SUNNYVALE**

WHEREAS, a resident of Sunnyvale has requested a street name change of Capella Way and on April 26, 2011, the City Council approved changing the street name of Capella Way to Olson Way in recognition of the Olson family, long-time residents of Sunnyvale, who have had significant impacts on the community and its agricultural history; and

WHEREAS, all public agencies, businesses and the public having an interest in the street name change have been contacted and have no objection to the change of name; and

WHEREAS, Streets and Highways Code Section 5026 provides that the City Council may by resolution change the name of any street located in the City of Sunnyvale;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYVALE THAT:

1. The street currently named Capella Way is hereby renamed Olson Way.
2. The City Clerk is directed to file a certified copy of this resolution with the Board of Supervisors, the Clerk and the Surveyor of Santa Clara County.
