

**Council Meeting: July 19, 2011****SUBJECT: Award of Contract for Uniforms and Equipment for the Department of Public Safety (F1005-110)****BACKGROUND**

Approval is requested to award a contract in the amount of \$324,000 to Summit Uniforms of San Jose, CA. for uniforms and equipment as required by the Department of Public Safety for a three-year period.

Uniforms and equipment are provided for Public Safety Officers pursuant to the City's Memorandum of Understanding (MOU) with the Public Safety Officers Association and in compliance with the Department of Public Safety General Orders Manual. Uniforms are also provided to some non-sworn employees working in support functions, such as Animal Control, Crime Prevention, Property and Evidence, and Records. In addition to uniforms, equipment items provided under the MOU and purchased for Public Safety Officers include gun holsters, gun belts, batons, handcuffs, and ballistic vests.

Public Safety recruits are provided uniforms and equipment as they pass each stage of training while at the academies. Upon graduation, they are provided any additional uniforms and equipment they need to continue training in the field as well as perform all duties assigned after the training phase has ended.

The total cost to uniform and equip a Public Safety recruit from police academy through fire and EMS academies to full-time Public Safety Officer is approximately \$8,600. Of this total cost, approximately \$4,500 worth of uniforms and equipment are purchased from Summit Uniforms. Fire turnout pants and jackets, firearms, and ammunition are also provided but purchased under separate purchase orders with different companies.

DISCUSSION

Bid specifications were prepared by the Department of Public Safety. Purchasing staff issued Invitation for Bids No. F1005-110, which was mailed directly to four potential bidders and broadcast to potential suppliers through the City's Onvia DemandStar public procurement network.

Sealed bids were due and publicly opened on June 15, 2011. One bid, from Summit Uniforms, was received.

The current contract will expire on July 31, 2011. Staff recommends that Council award a new three-year contract to Summit Uniforms, beginning August 1, 2011.

Summit maintains a reliable inventory, has on-site tailors for immediate alterations, completes rush orders at no additional cost, and is located within a reasonable distance of Sunnyvale.

FISCAL IMPACT

It is anticipated that the total cost to the City for the three-year contract will not exceed \$324,000. Of this amount, approximately \$279,000 will be expended to maintain and replace uniforms for existing staff. This amount is comparable to annual expenditures for replacement uniforms over the past few years. The remainder of the total contract amount (approximately \$45,000) will be expended to support new recruits in FY2013/2014 (currently estimated at ten individuals). While Summit's uniform and alterations pricing have remained unchanged since 2009, equipment pricing has increased from 7% to 15%. Summit Uniforms is offering to hold pricing for the three-year contract term.

Funds are available in the operating budget for Department of Public Safety Program 477 – Public Safety Administration and in various Recruitment, Selection and Training of Public Safety Officers Special Projects.

PUBLIC CONTACT

Public contact was made by posting the Council agenda on the City's official-notice bulletin board outside City Hall, at the Sunnyvale Senior Center, Community Center and Department of Public Safety; and by making the agenda and report available at the Sunnyvale Public Library, the Office of the City Clerk and on the City's Web site.

RECOMMENDATION

It is recommended that Council award a three-year contract to Summit Uniforms, in substantially the same form as the attached draft blanket purchase order and in an amount not to exceed \$324,000, for Public Safety uniforms and equipment.
