Residency Requirements

The City of Sunnyvale requires **proof of residency** in order to receive priority registration, discounted resident fees, or to qualify for Recreation Fee Waiver Programs. Any person who permanently resides in the City of Sunnyvale may qualify for the residency benefits. A minor who cannot prove residency on their own, must be accompanied by a parent or guardian who has qualified as a Sunnyvale resident.

Two forms of identification with the same name and address are required in order to qualify as a resident. One form of identification must be a picture ID. The following is a list of acceptable forms of identification.

A customer will only have to provide proof of Sunnyvale residency at the opening of a new account and any time there is an address change within Sunnyvale. If mail is returned from a Sunnyvale address, re-verification of residency may be required. Additionally, proof of Sunnyvale residency may be required on a periodic basis as determined by a Recreation Manager.

The start of our Sunnyvale resident verification policy will begin in conjunction with the implementation of our new software program. This policy will be effective October 1, 2005, for the November/December – January/February guide. **Proof of residence will be required for Sunnyvale residents only.**
