**Day 1 (July 16)** Today let the excitement build as we fly from Northern California to **Seattle**, Washington. Enjoy the beautiful lush greenery as the plane makes its approach. We will make our way to **Vancouver, BC** to start our adventures with a welcome dinner this evening. Hotel accommodations for the next 2 evenings are in Vancouver. (D)

**Day 2 (July 17)** Surrounded by majestic mountains, sparkling ocean and beautiful foliage, this bustling west coast seaport of **Vancouver** is a popular filming location and you may see cameras rolling as you stroll around and explore. We will visit **Stanley Park, Gastown, Chinatown, Canada Place** and enjoy a panoramic view of **English Bay**. (B)

**Day 3 (July 18)** After breakfast we board the ferry to the charming city of **Victoria, BC**. It's beginnings as a British colony are reflected in its Victorian architecture and in its many formal gardens. On our **city tour**, you will see the special beauty of Victoria's buildings and landscape. Included are the **Parliament Buildings, Chinatown, Fairmont Empress Hotel, Bastion Square, Thunderbird Park** and more. (B)

**Day 4 (July 19)** Wake up to a beautiful morning, have breakfast and then it's off to **Butchart Gardens**, truly one of the world's most famous displays of flowering beauty, where you will have time to stroll, browse and enjoy. In the late afternoon we go to **Sydney** to catch the ferry destined for **Friday Harbor**. (B)

**Day 5 (July 20)** You will certainly delight in today's visit to historic **Roche Harbor Resort, Sculpture Park, English Camp** and **Alpaca Farm**, with an afternoon **cruise**

of the **San Juan Islands**. Upon our return you may want to visit the **Whale Museum** the first U.S. Museum dedicated to a species living in the wild, the Orca. Evening is at your leisure. (B)

**Day 6 (July 21)** . Today we tour the **American Camp** and **Lavender Farm** on the island. There will be time to browse and wander the quaint Friday Harbor stores, boutiques and galleries upon our return. Enjoy socializing at our hosted farewell dinner tonight. (B, D)

**Day 7 (July 22)** A morning ferry back to the mainland starts our journey home. We'll get you to the Seattle-Tacoma Airport for your flight home, as you say good-bye to all your new friends. (B)
