Paper Bag Guidelines:

City of Sunnyvale Single Use Bag Carryout Bag Ordinance (5.38.010 (E&H)) states:

E. Postconsumer recycled material that would otherwise be destined for solid waste disposal, having completed its intended end use product life cycle. "Postconsumer recycled material" does not include materials and by-products generated from, and commonly reused within, an original manufacturing and fabrication process. (H.) "Recyclable paper carryout bag" means a paper bag that meets all of the following requirements. (1) Is one hundred percent (100%) recyclable overall and contains a minimum of forty percent (40%) post-consumer recycled material; (2) is capable of composting, consistent with the timeline specifications of the American Society of Testing and Materials (ASTM) Standard D6400; (3) is accepted for recycling in curbside programs in the City (4) has printed on the bag the name of the manufacturer, the location (country) where the bag was manufactured, and the minimum percentage of the postconsumer recycled material used; and (5) displays the word "Recyclable" in a highly visible manner on the outside of the bag.

Paper Bag Guidelines:

City of Sunnyvale Single Use Bag Carryout Bag Ordinance (5-38.010 (E&H)) states:

E. Postconsumer recycled material that would otherwise be destined for solid waste disposal, having completed its intended end use product life cycle. "Postconsumer recycled material" does not include materials and by-products generated from, and commonly reused within, an original manufacturing and fabrication process. (H.)

"Recyclable paper carryout bag" means a paper bag that meets all of the following requirements. (1) Is one hundred percent (100%) recyclable overall and contains a minimum of forty percent (40%) post-consumer recycled material; (2) is capable of composting, consistent with the timeline specifications of the American Society of Testing and Materials (ASTM) Standard D6400; (3) is accepted for recycling in curbside programs in the City (4) has printed on the bag the name of the manufacturer, the location (country) where the bag was manufactured, and the minimum percentage of the postconsumer recycled material used; and (5) displays the word "Recyclable" in a highly visible manner on the outside of the bag.
