

**NOTICE OF CONSIDERATION OF PROPOSED ACTION BY THE OVERSIGHT BOARD
FOR THE SUCCESSOR AGENCY OF THE FORMER SUNNYVALE REDEVELOPMENT
AGENCY TO DIRECT AND RATIFY THE TRANSFER OF SPECIFIC GOVERNMENTAL
USE ASSETS TO THE CITY OF SUNNYVALE**

NOTICE IS HEREBY GIVEN that, at its public meeting on Thursday, September 24 2015, at 4 p.m. in the City Council Chambers located at 456 W. Olive Avenue, Sunnyvale, California, the Oversight Board (the "Oversight Board") for the Successor Agency (the "Successor Agency") of the former Redevelopment Agency of the City of Sunnyvale (the "Dissolved Redevelopment Agency") will consider the action described below to direct and approve the conveyance to the City of Sunnyvale (the "City") of a parcel of property now owned by the Successor Agency and used for governmental purposes (the "Proposed Transfer Property") in the City of Sunnyvale. The Proposed Transfer Property is located at 200 West Evelyn Avenue and identified as Assessor's Parcel Number 209-07-025.

Upon dissolution of the Dissolved Redevelopment Agency on February 1, 2012, the ownership of the Proposed Transfer Property transferred to the Successor Agency pursuant to Health and Safety Code Section 34175(b). The Successor Agency is now responsible for the disposition of the Property in accordance with the procedures and requirements of ABx1 26 and AB 1484, the statutes that govern the dissolution of the Dissolved Redevelopment Agency and the disposition of its former property.

At the above noticed public meeting, the Oversight Board will consider whether to direct the Successor Agency to transfer the Proposed Transfer Property to the City in accordance with Health and Safety Code Section 34181(a). Health and Safety Code Section 34181(a) expressly authorizes the transfer to the City of properties that are used for governmental purposes.
