2. Approval of the 2016 Modified and Restated Amended Disposition and Development and Owner Participation Agreement for the Sunnyvale Town Center.

2. Find that the 2016 MRADDOPA reduces the Successor Agency's liabilities, increases the revenues to the taxing entities and therefore is in the best interest of the taxing entities.
3. Adopt the modified Resolution approving the 2016 Modified and Restated Amended Disposition and Development and Owner Participation Agreement between the Successor Agency of the Former Redevelopment Agency of the City of Sunnyvale and STC Venture, LLC and related documents.
