1. **2007-1306** – Application for a Use Permit to allow a 7’ 7” tall fence in the side yard. The property is located at **594 E Fremont Avenue** (near Floyd Ave.) in an R-0 (Low Density Residential) Zoning District. (APN: 309-03-035) NC **(This item has been continued to the February 13, 2008 Administrative Hearing)**
2. **2007-1338** – **American Kickboxing Academy** [Applicant] **Murray Garnet Trustee** [Owner]: Application for a Special Development Permit to allow a recreational use at the Fremont Corners Shopping Center. The property is located at **168 E. Fremont Ave** (near Sunnyvale-Saratoga Rd.) in a C-1/PD (Neighborhood Business/Planned Development) Zoning District. (APN: 309-01-006) SL
3. **2007-1287** – Application for a Special Development Permit to allow an 8’ 10” tall accessory utility building (arbor) with a 0’ rear yard setback at a single-family residence. The property is located at **514 Cottage Grove Terrace** (near Yukon Dr.) in an R-2/PD (Low-Medium Density Residential/Planned Development) Zoning District. (APN: 323-47-020) NC
4. **2007-1257** – **Kensington Place Apartments** [Applicant] **Kensington-Fair Oaks Associates Joint Venture** [Owners]: Application for a Variance from Sunnyvale Municipal Code 19.44.140(c) to allow an 8’ 1” tall ground sign where 5’ is allowed in a residential zoning district. The property is located at **1220 N. Fair Oaks Ave.** (near Tasman Dr.) in an R-4/PD (High-Density Residential/Planned Development) Zoning District. (APN: 110-29-025) MH
