**PUBLIC HEARINGS/GENERAL BUSINESS**

1. **2008-1240** – Appeal by the applicant of a decision of the Director of Community Development of a Condition of Approval of a Miscellaneous Plan Permit for a 3-foot front yard fence located at **1384 La Bella Ave.** (APN: 323-08-019) RK (***Applicant requests continuance to April 27, 2009.***)

**ACTION: Comm. McKenna made a motion on 2008-1240 to continue this item to the April 27, 2009 Planning Commission meeting. Comm. Hungerford seconded. Motion carried, 6-0, with Comm. Klein absent.**

**APPEAL OPTIONS: This action serves as legal notification of the continuance of this item.**

2. **2009-0022 - California Ezra Bible Academy** [Applicant] **Chan Yeh Trustee** [Owner]: Application for a Use Permit to allow an institution of higher learning (educational use) at an approximately 10,816 square foot tenant space within a multi-tenant industrial building. The property is located at **532 Mercury Drive** (at Midas Wy.) in an M-S (Industrial & Service) Zoning District. (Mitigated Negative Declaration) (APN: 216-44-063) NC (***Continued from March 9, 2009.***)

**ACTION: Comm. McKenna made a motion on 2009-0022 to adopt the Mitigated Negative Declaration and approve the Use permit with modified conditions; to add a condition that all enrolled students shall be provided with a copy of the most current Site Safety Plan for review and sign off. Vice Chair Chang seconded. Motion carried, 4-2, with Chair Rowe and Comm. Sulser dissenting, and Comm. Klein absent.**

**APPEAL OPTIONS: This action is final unless appealed to the City Council no later than April 28, 2009.**

- 3. 2008-1259 – M Design Group [Applicant] Muhammed Irfan Et Al [Owner]:** Application for related proposals located at **585 Old San Francisco Road** (near S Fair Oaks Ave) in an R-3/PD (Medium-Density Residential/Planned Development) Zoning District. (APN: 209-33-003) SL;

- **Tentative Parcel Map** to subdivide one lot into 6 condominium lots and 1 common lot.
- **Special Development Permit** to allow 6 new town homes.
- **Variance** to allow individual solid waste bin carts.

**ACTION: Comm. Hungerford made a motion on 2008-1259 to deny the Special Development Permit, Variance, and Tentative Map. Comm. McKenna seconded. Motion carried, 5-1, with Vice Chair Chang dissenting, and Comm. Klein absent.**

**APPEAL OPTIONS: This action is final unless appealed to the City Council no later than April 28, 2009.**
