### 1.A. APPROVAL OF MINUTES of June 27, 2011

- 1.B. 2011-7331 - Design Review to allow a one-story addition at **920 Mockingbird Ln.** resulting in 2,843 square feet and 48.2% Floor Area Ratio (FAR), where 45% FAR may be allowed without Planning Commission review. NC

**Comm. Sulser moved to approve the Consent Calendar. Comm. Chang seconded. Motion carried 5-0, with Comm. Kolchak abstaining on item 1.A. and recusing himself on item 1.B., and Chair Travis absent.**

## PUBLIC HEARINGS/GENERAL BUSINESS

2. 2010-7672 - Toll Brothers [Applicant] **Josephine Angelo Trustee** [Owner]: Special Development Permit and Vesting Tentative Map to allow 51 new single-family homes at **700 Timberpine Ave.** (Mitigated Negative Declaration) SL (*Staff requests continuance to July 25, 2011.*)

**ACTION: Comm. Chang made a motion on 2010-7672 to continue this item to the Planning Commission meeting of July 25, 2011. Comm. Dohadwala seconded. Motion carried 6-0, with Chair Travis absent.**

**APPEAL OPTIONS: This action serves as legal notification of the continuation of this item to the July 25, 2011 Planning Commission meeting.**

3. 2011-7290 - Design Review for a new two-story home on a vacant lot at **718 Hibernia Ct.** resulting in 3,004 square feet and 50% Floor Area Ratio (FAR), where 45% FAR may be allowed without Planning Commission review. SM (*Continued from June 27, 2011.*)

**ACTION: Comm. Sulser made a motion on 2011-7290 to approve the Design Review with modified conditions: to strike condition PS-1.a allowing the plate height for the second floor to remain at 9 feet; and to modify condition PS-1.c striking the requirement for high sill windows on the left side and for the applicant to obtain a letter from the immediate neighbor on the right side indicating that there is no objection to the lower sill windows, allowing the second story windows as proposed. Comm. Dohadwala seconded. Motion carried 6-0, with Chair Travis absent.**

**APPEAL OPTIONS: This action is final unless appealed to the City Council no later than July 26, 2011.**

4. **2011-7340** - Appeal of a decision by the Director of Community Development denying a Tree Removal Permit for three of six trees at **1402 Kelowna Ct.** RK

**Vice Chair Hendricks** recused himself and left the Council Chambers as he knows the appellant.

**ACTION: Comm. Sulser made a motion on 2011-7340 to deny the appeal and uphold the decision of the Director of Community Development to deny a portion of the Tree Removal Permit. Comm. Larsson seconded. Motion carried 4-1, with Comm. Dohadwala dissenting, Vice Chair Travis recusing himself, and Chair Travis absent.**

**APPEAL OPTIONS: This action is final.**

**Vice Chair Hendricks** returned to the Council Chambers for Agenda remainder of the meeting.

5. **2011-7296 - Classic Communities** [Applicant] **GMMSC Partners** [Owner]: Special Development Permit and Vesting Tentative Map to allow 17 townhome units on an existing industrial property at **1060 Morse Ave.** SM

**ACTION: Comm. Larsson made a motion on 2011-7296 to continue this item to the July 25, 2011 Planning Commission meeting to: address the deviations in usable open space, including pursuing the deck option; get more information on how the deviations relate to other projects; and, address the deviation in required parking. Comm. Dohadwala seconded. Motion carried 6-0, with Chair Travis absent.**

**APPEAL OPTIONS: This action serves as legal notification of the continuation of this item to the July 25, 2011 Planning Commission meeting.**

6. **Standing Item: Potential Study Issues** – No new items discussed.

7. **Election of Chair**

**Trudi Ryan**, Planning Officer, said Council Policy is that each year the Boards and Commissions select a chair and vice chair at the end of their first meeting in July to allow time for the chairs and vice chairs to receive training. She explained the election process.

**ACTION: Comm. Larsson nominated Vice Chair Hendricks to serve as the Chair of the Planning Commission for the 2011-2012 year. Vote was unanimous, 6-0, with Comm. Travis absent.**

## 8. Election of Vice Chair

**ACTION: Comm. Chang nominated Comm. Larsson to serve as the Vice Chair of the Planning Commission for the 2011-2012 year. Vote was unanimous, 6-0, with Comm. Travis absent.**

## 9. Selection of Seats

**Ms. Ryan** explained the seating selection process and said the seniority of the Commissioners are: Comm. Sulser, Comm. Chang, and Comm. Travis, Comm. Dohadwala, Comm. Hendricks, Comm. Larsson (determined in 2010 through a selection process) and Comm. Kolchak.

The commissioners selected their seats for the 2011-2012 year. The results of the selection resulted in the following seating arrangement: Comm. Kolchak, seat one; Comm. Dohadwala, seat two; Comm. Chang, seat three; Chair Hendricks, seat four; Vice Chair Larsson, seat five; Comm. Sulser, seat six; and Comm. Travis, seat seven.

**Ms. Ryan** said the new seating arrangement would begin at the July 25, 2011 Planning Commission meeting.
