Re: Application to be on Sunnyvale's List of Approved Backflow Prevention Testers, Installers and Repairers – July 1, 2024 – June 30, 2025

Dear Prospective or Returning Applicant,

As mandated by the State Water Resources Control Board and in accordance with Sunnyvale Municipal Code 12.28, the City of Sunnyvale establishes an annual list of companies who are approved to perform backflow prevention device testing, installation, and repairs within the City of Sunnyvale boundaries. All qualified companies are invited to re-apply. A summary of the general requirements is included, along with the application and checklist of required documents. Please allow up to four weeks for your application to be reviewed and processed, and for your company to be added to the list of approved testers, installers, and repairers.

The City will not accept test results from companies whose information is not current and have not paid an annual Backflow Installation, Removal and Relocation Testing Company fee. Only those companies who complete the application and, throughout the list period, provide updated information regarding tester certifications, insurance, test kit calibration certificates and other necessary information, will be acceptable for testing in Sunnyvale between July 1, 2024 and June 30, 2025. Companies on the City's existing list will be removed after June 30, 2024, if a new application with the required documentation has not been completed and approved.

General Requirements to Be on Sunnyvale's List of Approved Backflow Prevention Testers, Installers and Repairers

The following criteria must be met in order to apply for a company to be included on the City's list of approved backflow prevention testers, installers and repairers. Please review this list prior to completing and submitting the application for review.

- 1. All applicants and/or companies and each tester working for the applicants/companies must be certified and be current as American Water Works Association Backflow Prevention Assembly General Testers.
- 2. Applicant and/or company must have tested a combined total of 100 backflow devices within the last two years.
- 3. All applicants and/or companies must have a current State of California Contractor's License C-36, A, or B.
- 4. All applicants and/or companies must have a current City of Sunnyvale Business License.
- 5. Applicant and/or company must maintain general liability insurance in full force and effect, for all activities performed under the permit. Such insurance must include coverage for bodily injury, personal injury, including death resulting therefrom, and property damage insurance, with limits not less than \$1 million each occurrence combined single limit. A cross-liability clause must be attached. The insurance must provide 30-day prior written notice of cancellation, non-renewal, or material change to the Sunnyvale Department of Finance.
- 6. Applicant and/or company must obtain an annual Backflow Testing Permit from the City of Sunnyvale and pay the associated fee.
- 7. Applicant and/or company must provide the test kit serial number and date of calibration for each tester. Any new kits put into service mid permit cycle will require a calibration certificate to be submitted.
- 8. If applicant and/or company wishes to test backflow prevention devices supplied by recycled water, applicant/company must provide test kit serial number and date of calibration for a test kit(s) dedicated to such use.
- 9. Applicant and/or company must not have been removed from another Agency's list, reprimanded by or subject of an investigation by an agency, or water utility related to backflow prevention device testing, installation, and repair or reporting.
- 10. Applicant and/or company must not have engaged in dishonest or illegal business practices or installed, repaired, or tested devices in a negligent manner within the City of Sunnyvale.

- 11. Applicant and/or company must not have performed backflow prevention installation, removal, replacement, or relocation within City limits without first obtaining a Backflow InspectionPermit and City approval.
- 12. Applicant and/or company must not have any unresolved customer complaints reported to the City, the Better Business Bureau, or the State Contractor's License Board.
- 13. The City may suspend or revoke approval of an individual tester and or company from the list of approved testers without notice if the individual or company fails or refuses to comply with the City's Cross-Connection Control Program Policies and Regulations, engages in dishonest business practices in the City of Sunnyvale, or fails to maintain a valid "Backflow Prevention Assembly Tester Certificate" from the American Water Works Association, Sunnyvale business license, general liability insurance, Contractor's License C-36, A or B, test kit calibration; or installs, repairs or tests the devices in a negligent manner. Failure to abide by any of these requirements may be grounds for exclusion from the approved testers list for a period of up to (2) two years.
